POSITION:

As a member of the Ongwanada Management Team, the Clinical Manager is responsible for providing leadership and supervision to behaviour therapists and direct support professionals, along with efficient and effective implementation of behavioural supports and services for persons diagnosed with a Developmental Disability.

DUTIES AND RESPONSIBILITIES:

- Oversight and monitoring of various learning and behaviour assessments (e.g. stimulus preference assessments, AFLS, functional behaviour assessments);
- Develop, implement and monitor individualized treatment and behaviour support plans in accordance with legislation, and compliance standards;
- Support service coordination efforts to ensure access and integration for all clients within Ongwanada, and with key external stakeholders;
- Ensure adherence to professional standards of service consistent with legislative requirements including the Psychology and Applied Behaviour Analysis Act, 2021, and directives and expectations of Ongwanada;
- Ensure service targets are met;
- Monitor budget allocations and reporting on variances;
- Perform “On-Call” duty during “off hours” as required.

- Current clinical expertise and knowledge of Developmental Services and Autism Spectrum Disorder;
